As well as any support from the Government and local administrations for creating and developing logistic infrastructure.

Bulgaria joined EU in 2007. The big European Market was opened for our transport, freight forwarding and logistic companies. At first glance yes but getting deeper into the matter we realize that to serve the transportation between Western Europe(Germany, France, Italy and etc.) and Turkey and Western Europe and Russia for example we are required to have 3<sup>rd</sup> country permits. Why because road transports are still governed by the ancient system of bilateral agreements between the countries. We have raised the topic as high as possible via the structures of FIATA and CLECAT but the agreements between the separate countries are still in force.

Another considerable challenge to our transport and logistic sector is the minimum wage system

that some of the West European countries jointly decided to apply.

Therefore we once more express our support to projects such as the Inter modal Terminal in Plovdiv that will open opportunities to Bulgarian logistic companies to make business and grow within Bulgaria.

Our sea ports and especially their container terminals have been outdated for long time. We truly hope developing the terminal in Plovdiv is a clear sign that the Administration has realized the vital need of logistic infrastructure not only for the freight forwarding and transport industry but for the whole economy of the country. It is clear that such infrastructure projects could work efficiently only in joined network. We herewith appreciate the decision of the Government, expressed by Mr. Moskovski to build a network of inter modal terminals. The ports of Varna and Burgas should be very soon modernized to enable sustained growth of the sector and support the growth of the Bulgarian Economy. So that most of the 57 000 TEU that were reported as capacity of Plovdiv terminal to enter and exit via Bulgarian ports.
